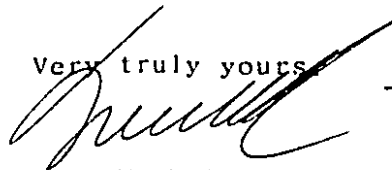

The undersigned incorporator, for the purpose of forming a corporation under the Florida Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE ONE: NAME OF CORPORATION

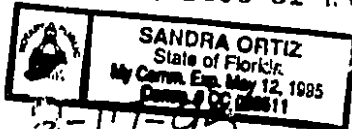
