THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES OF INCORPORATEDM, EXCH A RATURAL PERSON, COMPETENT TO CONTRACT, HERBY ASSOCIATE THRMSELVES TOGETHER TO FORM A COMPORATION FOR PROFIT UNDER THE LAWS OF THE STATE OF FLORIDA; AND DO AGREE TO THE FOLLOWING CONDITIONS OF SAID CORPORATION:

ARTICLE I: HAME
