The undersigned incorporator of SEE YA, INC., hereby forms a corporation for profit under the Florida General Corporation Act and other laws of the State of Florida.

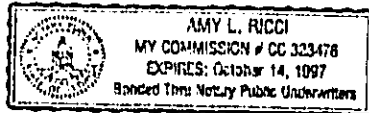
