KNOW ALL NEW BY THESE PRESENTS: That the undersigned person acting as incorporator of a corporation under the florid feneral Corporation Act, adopts the following Articles of Incorporation for such corporation:

### ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be WELLINGTON TREE FARM & LANDSCAPE, INC.

### ARTICLE II - DURATION OF MAISTENCE

This corporation shall exist perpetually, commancing on the date these Articles are filed in the Office of the Secretary of State.

### ARTICLE IV - GENERAL PURPOSES
