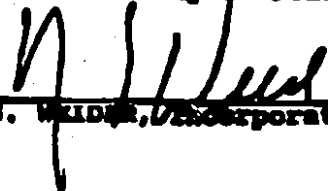
- FIRST: The name of the Corporation is COMMERCIAL VENDING, INC. (the "Corporation").
