ARTICLE I - NAME

The name of this Corporation is BOB AND ROB PAINTING, INC. whose principal office and mailing address is: 4240 N.W. 116 Avenue, Sunrise, Florida 33323.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.

ARTICLE III - PURPOSE

This Corporation is organized for the following purposes:

A. To engage in all aspects of complete interior and exterior pressure cleaning and painting and the application of custom textures and wallpaper.

B. To engage in any lawful act or activity for which corporations may be organized under the law of the State of Florida.

C. To have and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon corporations organized pursuant to the laws under which this Corporation is organized and any and all acts amendatory thereof and supplemental thereto.

ARTICLE IV - CAPITAL STOCK


