**1. NAME**



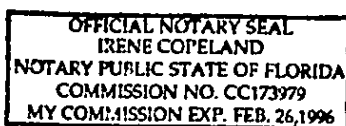


