The undersigned, acting as the incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

Article I - NAME

The name of the corporation is DR. VINYL OF COLLIER COUNTY, INC.

ARTICLE II - DURATION

The period of duration of the corporation is perpetual.

Article III - PURPOSE

The purpose for which the corporation is organized is to engage in any activity or business permitted under the laws of the United States and of this State, including, but not limited to, vinyl and leather repair.

Article IV - AUTHORIZED SHARES

Number. The aggregate number of shares that the corporation shall have the authority to issue is five hundred (500) shares of Capital Stock with a par value of \$1.00 per share.

<u>Initial issue</u>. Two hundred fifty-one (251) shares of Capital Stock of the corporation shall be issued as follows:

Stated capital. The sum of the value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.

<u>Dividends</u>. The holders of the outstanding capital stock shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.

No classes of stock. The shares of the corporation are not to be divided into classes.

No shares in series. The corporation is not authorized to issue shares in series.

Article V - REGISTERED AGENT

The initial street address in Florida of the initial registered

Article VI - NUMBER OF DIRECTORS

The initial board of directors shall consist of one (1) member, who need not be a resident of the State of Florida nor a shareholder of the corporation.

Article VII - NAME AND ADDRESS OF DIRECTOR

The name and address of the person who shall serve as director and officer until the first annual meeting of shareholders, or until his successors shall have been selected and qualified, is as follows:

ARTICLE IX - SHAREHOLDER ACTION

An affirmative vote of a majority of the shares of the corporation shall be required for any shareholder action.

Article X - AMENDMENT

The shareholders shall have the power to adopt, amend, alter, change or repeal the articles of incorporation when proposed and approved at a stockholders meeting, with not less than a majority vote of the common stock.

ARTICLE XI - PREEMPTIVE RIGHTS

The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, such of the shares of the stock of this corporation as may be issued for money, or any property or services from time to time, in addition to that stock authorized and issued by the corporation. The preemptive rights of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently

authorized and issued.
