The undersigned, for the purpose of forming a corporation under the //lorida General Corporation Act, hereby adopts the following articles of incorporation.

# ARTICLE Y - Name of corporation

The name of this corporation shall be: Dominican International Inc.

### ARTICLE II - Duration

The term of existence of the corporation is perpetual, commencing upon the filing of these Articles of incorporation with the Department of State, State of Florida.
