ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF CORE EMPLOYER SERVICES, INC.

The Articles of Incorporation of **CORE EMPLOYER SERVICES**, **INC.**, a Florida corporation (the "Corporation") are hereby amended as follows:

1. The Articles of Incorporation are amended by the addition of Article XI as follows:

"ARTICLE XI "Preemptive Rights

"Each shareholder of the Corporation shall have the first right to purchase shares of the Corporation of the same class, kind or series as that which the shareholder already holds that may from time to time be issued by the Corporation, whether or not presently authorized, including shares from the treasury of the Corporation, in the same ratio as the number of shares he holds at the time of issue bears to the total number of shares outstanding exclusive of treasury shares. shareholder may waive his or her preemptive rights. A waiver evidenced by a writing is irrevocable even though it is not supported by consideration. Preemptive right shall be deemed waived by any shareholder who does not exercise his or her preemptive rights and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the Corporation stating the prices, terms and conditions of the issuance of shares and inviting him or her to exercise his or her preemptive rights."
