Article 1

Name. The name of this Corporation is OCUDEX, INC.

Article II

Principal Office. The address of the principal office of the Corporation is 3713 S.W. 42nd Avenue, Suite 3, Gainesville, FL 32608.

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV

Purpose.
