The Corporation is authorized to issue One Hundred (100) shares of no par value common stock.

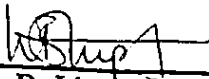

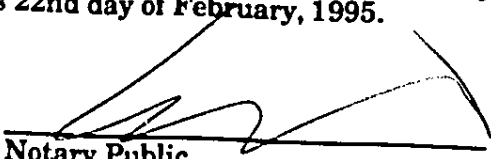

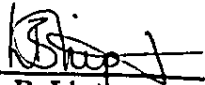
