The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

This corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation with the Secretary of State of Florida.

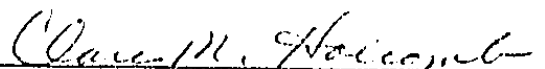
