ARTICLE I - NAME AND ADDRESS

The name of this corporation is SHULSEN & HOYER MANAGEMENT, INC. The address of the principal office is 216 Van Buren Drive, Sarasota, Florida 34236.

ARTICLE II - TERM

This corporation shall commence to exist on February 20, 1995 and shall exist perpetually or until legally dissolved.

ARTICLE III - PURPOSE

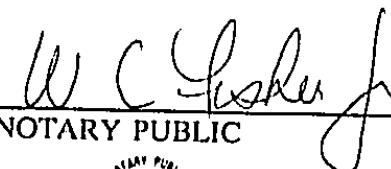
