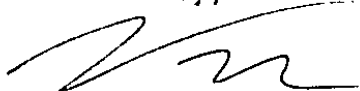

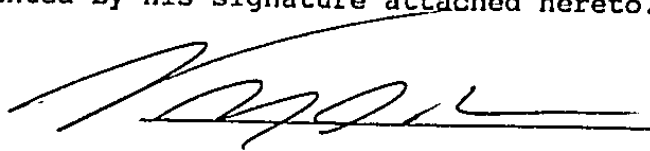

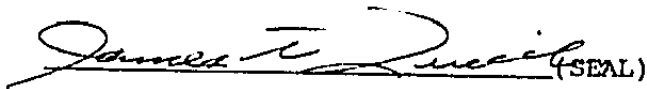

These articles may be amended in the manner provided by law.

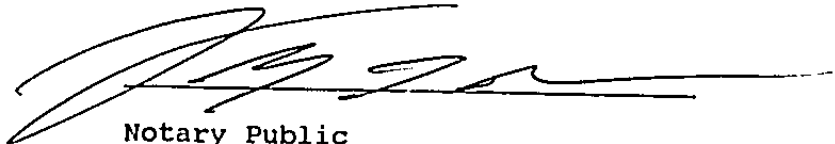
