## ARTICLES OF INCORPORATION OF C.M.T. IMPORT & EXPORT, INC.

We, the undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate together to form a corporation under the Laws of the State of Fiorida.

## ARTICLE I NAME OF CORPORATION

The name of the corporation shall be: C.M.T. IMPORT & EXPORT, INC.

#### ARTICLE II NATURE OF BUSINESS
