ARTICLES OF INCORPORATION

This corporation shall commance existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

To make contracts and guarantees and incur linbilities, bollow money at such rates of interest as the corporation may determine, issue its notes, bonds, and

other obligations, and secure any of its obligations by mortgage or plodge of all or any of its property, franchises, and incomes

To lond money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security of the payment of funds so loaned or invested;

To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this state;
