

ARTICLE 1 - NAME

The name of this Corporation is JOE'S AIR FREIGHT PICKUP AND DELIVERY SERVICES, INC.

ARTICLE 2 - DURATION

This Corporation shall have a perpetual existence.

ARTICLE 3 - PURPOSE
