CERTIFICATE OF INCORPORATION OF

DALE TREFELNER, P.A.

The undersigned, being duly licensed to engage in Real Estate Sales Management Consulting in the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be

DALE TREFELNER, P.A.

ARTICLE II

PURPOSE

The purpose for which the corporation is organized is to practice the profession of Real Estate Sales Management Consulting and to do all things necessary in connection therewith.

ARTICLE III

DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV

CAPITAL STOCK

The number of shares of stock that the corporation is authorized to have outstanding is 100, all of which shall be common shares without par value.

ARTICLE V

CAPITAL

The amount of stated capital with which the corporation shall

begin business is Fifty Dollars (\$50.00).

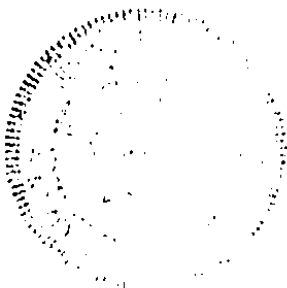


