ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be TOWN CENTER AUTOMOTIVE, INC.

ARTICLE II - CORPORATE ADDRESS

The principal office of the corporation and mailing address is 2271 NE 197th Street, North Miami Beach, FL 33179.

ARTICLE III - BEGINNING OF CORPORATE EXISTENCE

The existence of this corporation shall commence on the 27th day of February, 1995; provided that if such day be authorized under law, then on the earliest day allowable pursuant to Florida law for commencement of corporate existence.

The existence of this corporation shall be perpetual.

ARTICLE IV - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

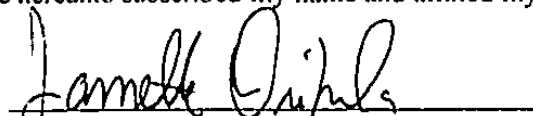
