ASTICLES OF INCORPORATION

WE, the undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the corporation laws of the State of Florida and the acts amendatory thereof and supplemental thereto, do hereby certify as follows:

ARTICLE I

The name of the Corporation and its address shall be:

J.V. CARPET TRANSPORTATION, INC. 6601 N.W. 82nd Avenue Miami, FL 33166

ARTICLE II

The Corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE III

The Corporation shall be organized for the following purposes:

A) To manufacture, produce, buy, lease, sell, rent, exhibit, distribute, install and deal in and with all kinds of carpeting and use of trucks or other vehicles appropriate for the carriage of carpets or goods, and to carry on the business of truck proprietor and carriers of carpet.

and powers of the Corporation, but it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this Corporation, and the Corporation may engage in any activity or business permitted under the laws of the United States of American and of the State of Florida.

- B) To engage in the manufacture, sale, purchase, holding, importing and exporting of merchandise and personal property of all manner and description; to act as principals of agents for the purchase, sale and handling of goods, wares, and merchandise of any and all types and descriptions for the account of the Corporation, or as factor, agent, procurer or otherwise for and on behalf of another;
- C) To manufacture, purchase or otherwise acquire, own, mortgage, pledge, sell, assign and transfer or otherwise dispose of, and to invest, trade, deal in and deal with, goods, wares, merchandise and real and personal property (tangible or intangible) of every class, kind and description;
- D) To contract debts and borrow money, to issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness as required;

- (c) To purchase the corporate assets of any other corporation and engage in the same or other character of business;
- transfer, mortgage, pledge, or otherwise acquire or dispose of the shares of the capital stock, or any bonds, securities, or other evidences of indebtness created or resued by any other person, firm, association or corporation, or by any state or government, demostic or fereign, and while owner thereof to exercise all the rights, powers and privileges of ownership, including the right to vote stock;
- 6) To enter into, make and perform contracts of every lind with any person, firm, association or corporation municipality, political body, country, territory, state, government or colony or dependency or agency thereof;
- H) To purchase, hold and ressue any of the shares of its capital stock;
- In general, to do each and everything necessary, suitable and proper for the accomplish of any of the purpose or the attainment of any of the objects of the furtherance of any of the powers herein above set forth, either alone or in association with other corporations, firm, or individuals, and to carry on any business, and to have all powers in connection therewith, not forbidden by the laws of the State of Florida, and to do every other act of acts, thing or thinge incidental or apportment to or growing out of acts of acts with the aforesaid objects or

purposes or any part or parts thereof.

J) To have and exercise all powers granted corporations under the laws of the State of Florida or any amendments thereof.

ARTICLE IV

The maximum number of shares of capital stock which this Corporation shall be authorized to have outstanding at any time shall be FIVE MUNDRED (500) shares of common stock, each share having the par value of ONE DOLLAR (\$1.00) all of which shall be of the same class and have the same distinguishing characteristics.

The amount of capital with which this Corporation shall commence business shall not be less than FIVE HUNDRED DOLLARS (\$500.00).

ARTICLE VI


