ARTICLES OF INCORPORATION OF

ORCI OCEANFRONT RESORT CLUB INTERNATIONAL, II

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I Name and Address

Section 1. The name of the Corporation shall be ORCI OCEANFRONT RESORT CLUB INTERNATIONAL, INC.

Section 2. The mailing address of the Corporation is c/o Joel B. Giles, Esquire, Powell, Carney, Moore, Hucks & Olson, P.A., 200 Central Avenue, Suite 1210, St. Petersburg, Florida 33701.

ARTICLE II Purpose and Powers

Section 1. The Corporation is formed for the purpose of engaging in any lawful activity or business for which corporations may be incorporated under the laws of the State of Florida.
