## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF AMERICAN COMMUNICATION TECHNOLOGIES, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is American Communication Technologies, Inc. (hereinafter referred to as the "Corporation").
- 2. Article IV of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

## ARTICLE IV CAPITAL STOCK

- A. <u>Authorized Shares</u>. This corporation is authorized to issue one hundred thousand (100,000) shares of common stock. Such shares shall be of single class and shall have no par value.
- Share Division. On the date of the filing of these Articles of B. Each certificate that heretofore represented issued and outstanding shares of Old Common Stock shall now represent the number of shares of Common Stock into which the shares of Old Common Stock represented by such certificate were divided, reclassified and converted; provided, however, that each person holding of record a stock certificate or certificates that represented outstanding shares of Old Common Stock shall receive, upon surrender of each such certificate or certificates, a new certificate or certificates evidencing or representing the number of shares of Common Stock to which such person is entitled.
- 3. The foregoing amendment was adopted by all of the directors of the Corporation by written consent dated the 14th day of August, 1998, in accordance with the provisions of Section 607.0821 of the Florida Statutes, and by all of the shareholders of the Corporation by written consent dated the 14th day of August, 1998, in accordance with the provisions of Section 607.0704 of the Florida Statutes.
