The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is Min-Joy Imports, Inc.

CORPORATE DURATION

The duration of the corporation is perpetual.
