The undersigned, acting as incorporator of Comprehensive Podiatry Associates, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE ONE - NAME

ARTICLE THREE - COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on March 1, 1995.

ARTICLE FOUR - PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE FIVE - AUTHORIZED SHARES


ARTICLE NINE - BYLAWS
