ARTICLES OF INCORPORATION OF WILLIAMS MASSAGE THERAPY, INC.

The undersigned Incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME

The name of this corporation shall be Williams Mansage Thorapy, Inc.

ARTICLE II. PURPOSE AND NATURE OF CORPORATION

The purpose of the Corporation and the nature of its business are as follows:

- 1. To provide neuromuscular and therapeutic massages:
- 2 To generally engage in and carry on any business incidental to the provision of neuromuscular and thorapeutic massage services;
- 3. To purchase and own real and personal property necessary or desirable for the provision of neuromuscular and therapeutic massage services;
- 4. To do everything necessary, proper, or convenient for the accomplishment of any of the purposes set forth herein; and,
- 5. To engage in and transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act and other incorporation laws of the State of Florida. No other purpose stated herein shall limit this general purpose in any way.

ARTICLE III. COMMENCEMENT OF EXISTENCE AND DURATION

The Corporation shall commence existence as of the date of subscription and acknowledgment of these Articles, except that if they are not filed by the Florida Department of State within five (5) business days after that date, then corporate existence shall commence upon filing by the Department of State. The Corporation shall have perpetual existence.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is one hundred (100) shares, having a par value of one dollar (\$ 1.00) per share.
