ARTICLES OF INCORPORATION OF

ARTICLE I. NAME

The name of this corporation shall be COMPUTER SALES UNLIMITED, CORP.

ARTICLE II. DURATION

The period of the corporation's duration shall be perpetual or until dissolved as permitted by law.

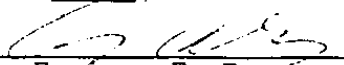
