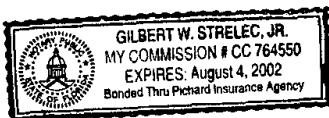
1. Timothy S. Kanai is the Director of KACO SIGNS, INC., a Florida corporation, (hereinafter "Corporation").
