**ARTICLES OF INCORPORATION  
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE 1: NAME**

The name of the corporation shall be: Take Up the Cross Music Ministries, Inc.

**ARTICLE 2: PRINCIPAL PLACE OF BUSINESS**

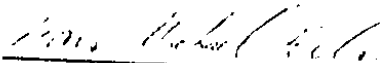
