ARTICLES OF INCORPORATION  
OF

I

The name of the corporation shall be CRADLE TO CRAYONS, INC.

None of the original stockholders shall sell or transfer any amount of stock without allowing the other shareholder the right of first refusal to purchase said stock.

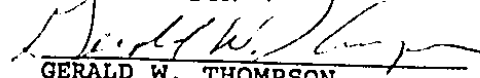
