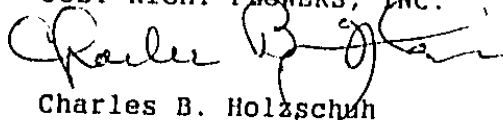

We, the undersigned, hereby associated ourselves together for the purpose of becoming a corporation under the General Corporation Law of the State of Florida.

ARTICLE I

The name of this corporation is JUST RIGHT FLOWERS, INC.

ARTICLE II

This corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these articles.

ARTICLE III

The general purpose for which this corporation is initially organized is to include the transactions of any lawful business for which a corporation may be incorporated under Florida Law, but initially this corporation shall be for the purpose of a florist shop.

ARTICLE IV

The maximum number of shares of stock of this corporation is authorized to have outstanding at any one time is FIVE THOUSAND (5000) SHARES of common stock, with a par value of ONE (\$1.00) DOLLAR per share. The whole or any part of the capital stock of said corporation shall be payable in lawful money of the United States of American, or property, labor, or services at a just valuation to be fixed by the Board of Directors. Property and labor may also be purchased with capital stock of said corporation at such valuation as shall be fixed by the Board of Directors.

The amount of capital with which this corporation will begin business is FIVE HUNDRED (\$500.00) DOLLARS.
