The undersigned do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Florida under the corporate name NoBo Enterprises of Sanibel, Inc., and hereby set forth and declare:

# CHARTER

## Article I

The name of the corporation shall be HoBo Enterprises of Sanibel, Inc., located at Fort Myers, County of Lee, State of Florida.

#### Article II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

#### Article III

The authorized capital stock which the corporation may issue shall be 10,000 shares of \$1.00 par value common stock, which shall be nonassessable and held, sold, and paid for at such time and in such manner as the Board of Directors may from time to time determine.

# Article IV

The corporation shall commence business on filing with the Secretary of State.

# Article V

The corporation shall have perpetual existence, except that the same may be dissolved, as provided by law.

A director or officer of the corporation shall not be disquallfied by his office from dealing or contracting with the corporation either as a vendor, purchaser, or otherwise, nor shall any transaction or contract of the corporation be void or voidable by reason of the fact that any director or officer or any firm of which any director or officer is a member or any corporation of which any director or officer is a shareholder, officer, or director, is in any way interested in such transaction or contract, provided that such transaction or contract is or shall be authorized, ratified, or approved either (a) by a vote of a majority of a quorum of the Board of Directors, without counting in such majority or quorum any director so interested or member of a firm so interested, or a shareholder, officer, or director of a corporation so interested, or (b) by the written consent, or hv the vote of any shareholders meeting of the holders of record, of a majority of all the outstanding shares of stock in the corporation entitled to vote, nor shall any director or officer be liable to account to the corporation for any profits realized by or from or through any such transaction or contract authorized, ratified, or approved as herein provided by reason of the fact that he, or any firm of which he is a member of any corporation of which he is a shareholder, officer, or director, was interested in such transaction or contract. Nothing herein contained shall create

liability in the events above described or prevent the authorized approval of such contracts in any other manner permitted by law.
