

ARTICLES OF INCORPORATION

OF

Health Essentials, Inc.

THE UNDERSIGNED SUBSCRIBERS to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I.

The name of this corporation shall be Health Essentials, Inc.

ARTICLE II.

The corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE III.

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ONE HUNDRED (100), which shall be at a par value of ONE DOLLAR (\$1.00).

The whole or any part of the capital stock of said corporation shall be payable in lawful money of the United States of America, or property, labor or services at a just valuation to be fixed by the stockholders. Property, labor or services may also be purchased with the capital stock at such valuation as shall be fixed by the stockholders.

ARTICLE IV.

The amount of capital with which the corporation will begin business is not less than ONE HUNDRED (\$100.00) DOLLARS.

ARTICLE V.

The corporation shall have perpetual existence unless sooner dissolved pursuant to law.

ARTICLE VI.

The initial address of the principal office of this corporation in the State of Florida is 5132 N.W. 43rd Avenue, Coconut Creek, Florida 33073, with the privilege, however, of having branch offices or places of business at any other place or places within or without the State of Florida or in foreign countries.


