WE THE UNDERSTORED, hereby associate ourselves together for 1935 PAR 1 PP 3: 00 the purpose of becoming a corporation under the laws of the State

of Florida, providing for the formation, liability, righted, RIDA privileges and immunities of corporations for profit.

ARTICLE 1 - NAME
