

### ARTICLES OF INCORPORATION

## BROOKFIELD MANAGEMENT, INC.

The undersigned incorporator to those Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

## ARCICLE L - NAME

The name of this corporation is BROOKFIELD MANAGEMENT, INC.

## ARTICLE LI - TERM OF EXISTENCE

The date when corporate existence shall commence shall be the date of the filing of these Articles of Incorporation by the office of the Secretary of State of the State of Florida and the corporation shall have perpetual existence thereafter.
