The name and address of the initial registered agent is Helen E. Scott, 128 Queen Christina Court, Fort Pierce, FL 34949-8364.

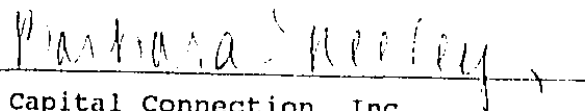
