

ARTICLE I

The name of this Corporation shall be:

GRACELAND INTERNATIONAL, CORP.

ARTICLE II

This corporation may engage in the transaction of any or all lawful business for which a corporation may be incorpotated under the Florida General Corporation Act of the State of Florida.

ARTICLE III
