ARTICLES OF INCORPORATION
OF
AccuMedical Billing, Inc.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract hereby subscribe as Incorporator of a corporation for profit under the laws of the State of Florida, and do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be AccuMedical Billing, Inc., and the principal place of business shall be 19907 Jodi Drive, Lutz, FL 33549.

ARTICLE II

The general nature of the business to be transacted by this corporation is a medical billing service corporation, and any and all other business or trade or activity permitted by the Laws of the United States and of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this corporation shall have outstanding at any one time is 1,000 shares of common stock, having a par value of \$1.00 per share.

ARTICLE IV

The amount of capital with which this corporation shall begin business shall be not less than FIVE HUNDRED DOLLARS.

ARTICLE V

The corporation shall have the power to create and issue, with or without any connection to the issue and sale of any shares of stock or other securities, rights, warrants or options entitling the holders thereof to purchase from the corporation any shares of its capital stock of any class or classes, upon such terms and conditions and at such times and prices, but not less than par if such shares have par value, as the Board of Directors may provide and which shall be incorporated in an instrument(s) evidencing such rights. In the absence of fraud, the judgment of the Directors as to the consideration of the issuance of such rights, warrants or options and the sufficiency thereof shall be conclusive.

ARTICLE VI

This corporation shall exist perpetually.

ARTICLE VII

The street address of the initial registered office of this corporation in the State of Florida is 19907 Jodi Drive, Lutz, FL 33549. The Board of Directors may from time to time, without amending these Articles move the registered office to any other address within the State of Florida.

The initial registered agent shall be ADELE P. RICHOLL, 19907 Jodi Drive, Lutz, FL 33549.

ARTICLE VII

The name and addresses of the members of the First Board of Directors are: ADELE P. RICHOLL, 19907 Jodi Drive, Lutz, FL 33549.

The above directors shall hold office for the first year of existence, and until her successor is elected.

ARTICLE VIII

The subscribers and initial officers of the corporation, and their addresses are as follows:

ADELE P. RICHOLL, President, Vice-President, Secretary, Treasurer, Subscriber.

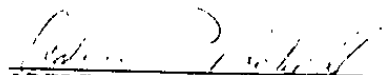
ARTICLE IX
