The undersigned, for the purpose of forming a corporation under the High General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be FILE-A-CORP^{InG} its principal business and mailing address is 901 Martin Downs Blvd., Suite 203, Palm City, Florida 34990.

The term of existence of the corporation is perpetual.
