ARTICLES OF INCORPORATION
OF
FILE-A-CORP, Inc.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be FILE-A-CORP^{Inc.} and its principal business and mailing address is 901 Martin Downs Blvd., Suite 203, Palm City, Florida 34990.

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

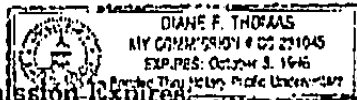
