ARTICLE I

The name of Corporation is L & M TRADING CORPORATION. The address of the corporation is 7713 West Pocahontas Avenue, Tampa, Florida, 33615.

ARTICLE II DURATION

The Corporation shall have perpetual existence.

ARTICLE III PURPOSE
