ARTICLES OF INCORPORATION OF ATILLA EAGLEMAN, M.D., P.A.

The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, Florida Statutes §621.01, et seq., hereby adopts the following Articles of Incorporation:

ARTICLE ONE

1.01 The name of this corporation is ATILLA EAGLEMAN, M.D., $P.\lambda$.

2.01 The corporation is to have perpetual existence.
