

ARTICLES OF INCORPORATION  
OF  
ATILLA EAGLEMAN, M.D., P.A.

The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, Florida Statutes §621.01, et seq., hereby adopts the following Articles of Incorporation:

ARTICLE ONE

1.01 The name of this corporation is ATILLA EAGLEMAN, M.D., P.A.

ARTICLE TWO

2.01 The corporation is to have perpetual existence.

ARTICLE THREE

3.01 The purpose for which the corporation is organized is to practice medicine. Further, the corporation shall have all powers permitted to a corporation under the Florida Business Corporation Act as extended to a Florida Professional Service Corporation under Florida Statute §621.13.

ARTICLE FOUR

4.01 The aggregate number of shares which the corporation shall have the authority to issue is 1,000, all of which shall be common shares with a par value of \$1.00 per share.

ARTICLE FIVE

5.01 The street address of the initial corporate office of the corporation is 2501 S. Seacrest Boulevard, Boynton Beach, Florida 33435.

5.02 The name and address of the initial Registered Agent for this corporation to accept service of process within the State of Florida is ATILLA EAGLEMAN, M.D., 2501 S. Seacrest Boulevard, Boynton Beach, Florida 33435.

ARTICLE SIX


ARTICLE EIGHT




