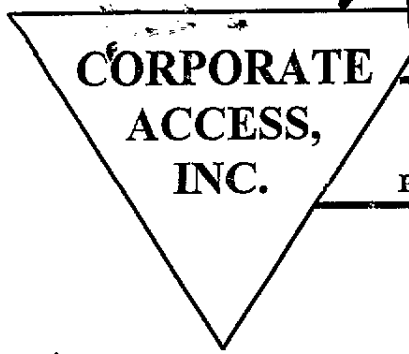

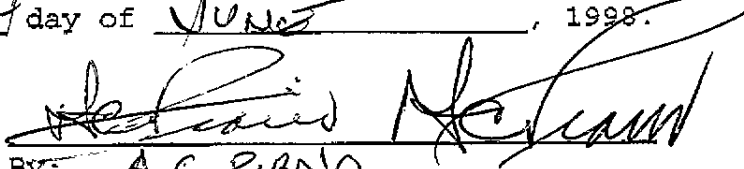

This Amendment was approved and adopted by written action of the Board of Directors and Shareholders of the Corporation effective of _____, the 24 day of JUNE, 1998.

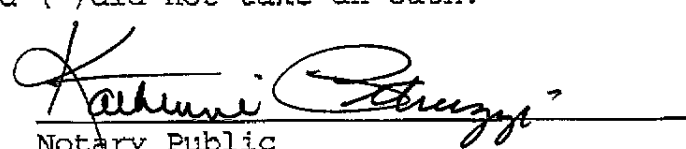
