ARTICLES OF INCORPORATION

OF

MR. WU'S CHINESE GOURMET OF GATEWAY MALL, INC.

ARTICLE I

NAME

The name of this Corporation is MR. WU'S CHINESE GOURMET OF GATEWAY MALL, INC. The address of the Corporation is 14497 N. Dale Mabry Highway, Suite 201, Tampa, FL 33618.

ARTICLE II

DURATION

This Corporation shall have perpetual existence.

ARTICLE III

NATURE OF BUSINESS

This Corporation is being formed for the following purposes:

To conduct any and all business activities permitted by the laws of the State of Florida.


