Article I - Name

The name of this corporation is TREASURE COAST PERSONNEL, INC.

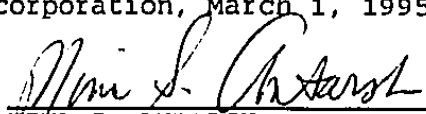

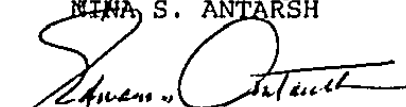
