

## FIRST AMENDMENT TO THE

## ARTICLES OF INCORPORATION

OF

## TREASURE COAST PERSONNEL, INC.

1. The following provisions of the Articles of Incorporation of TREASURE COAST PERSONNEL, INC., a Florida corporation, filed in Tallahassee on <a href="March 3">March 3</a>, 1995, be and they hereby are further amended in the following particulars:

Article IV, be and it hereby is amended as follows:

The aggregate number of shares that the Corporation is authorized to issue is 2,000 shares, divided into two classes. The designation of each class, the number of shares of each class, and the par value of the shares of each class are as follows:

Class	Number of Shares	•	<u>Par Value</u>
Class A Common	1,000		No
Class B Common	1,000		No

All common shares of both classes shall be identical in all respects except as hereinafter provided. The holders of the Class A common shares shall have exclusive voting rights and powers, including the exclusive right to notice of shareholders' meetings, except as otherwise provided in these Articles or by law.

2. The foregoing Amendment was adopted by unanimous consent of all stockholders entitled to vote on May 14 \_\_\_\_\_, 1999.
