ARTICLES OF INCORPORATION

FOR

THE BAGEL BASKET, INC.

ARTICLE I.

The name of the corporation is "The Bagel Basket".

ARTICLE II.

The duration of the corporation shall be perpetual. The date and time of the commencement of the corporate existence of the corporation shall be upon the execution of these Articles of Incorporation.

ARTICLE III.

The nature of the business and the objects and purposes to be transacted, promoted, or carried on by the corporation are to engage in any lawful act, activity or business for which corporations may be organized under the laws of the State of Florida.
