The undersigned incorporator, for the purpose of forming a corporation under Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be WINTER HAVEN AVIATION & REFINISHING, INC.

ARTICLE II

The existence of the corporation shall commence on March 6, 1995.

ARTICLE III
