NAME OF CORPORATION

The name of this corporation shall be:

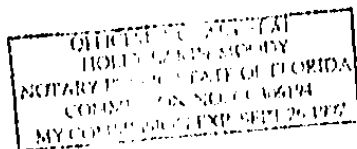
